- 1. The materials are accepted for publication are not intended for publication elsewhere.
- 2. The article should contain the following details:
 - The index of Universal Decimal Classification literature (UDC) (to be marked in the upper left corner);
 - title of the article (in Russian and English);
 - Surnames, names, patronymics of all authors in full (in Russian and English) indicating the scientific degree, rank and position;
 - full name of the organization and the city (full and abbreviated version) (Russian and English);
 - Abstract (consisting of 20-70 words, placed under the name of the organization, it is written in italics);
 - Abstract is in Russian and English languages;
 - The annotation is not permitted quoting;
 - a separate line stand 3-4 keywords (in English and Russian languages);
 - text of the article (7-12 pages, margins: left 30 mm, top and bottom 25 mm, right 15 mm, paragraph 1.25 cm, line spacing 1);
 - Page format B5 (17,6h25 cm);
 - the text of the manuscript are not allowed endnotes and page layout in landscape format;
 - the text of the manuscript are not allowed endnotes and page layout in landscape format; References (bibliographic references given at the end of the text in alphabetical order, in the text in square brackets indicates the serial number of the literature and a page, for example, [5, C.121]). Inline, descenders endnotes and bibliographical references (references) must be made in accordance with GOST R 7.05-2008 "bibliographic references. General requirements and rules", such as:

- 4. When typing text using the font Times New Roman (size 12 pt, line spacing 1).
- 5. Illustrations are performed in graphic editors in the form of black and white image files by a single entity. All the illustrations are accompanied by captions (not repeat the phrase, references to figures in the text), including number, name and illustration, if necessary symbols.
- 6. Be sure to specify in the text a reference to Fig. or tab. For example: (Fig. 1, Tab. 1) The drawings are executed in accordance with the following requirements: zoom the smallest (subject to legibility); letters and numerals in the figures in shape and size must comply with the symbols in the text; Picture Size less than 10x15 cm; text and symbols are removed from the picture in the text or captions.
